NOTICE OF INTENT TO DISMISS FOR FAILURE TO PROSECUTE

It appears that no action has been taken in this cause by filing of pleadings, order of court or otherwise for a period of (10) months.

IT IS ORDERED AS FOLLOWS:

1. Pursuant to rule 1.420(e) if no such record activity occurs within sixty (60) days following the service of this notice, and of not stay is issued or approved during such sixty (60) day period, this action shall be dismissed by the Court on it's own motion or of any interested person, whether a party to the action or not, after reasonable notice to the parties, unless a party shows good cause showing why the action should not be dismissed for want of prosecution.
2. The showing of good cause shall be in writing and filed in the action at least five (5) days before the hearing set in paragraph 3.
3. If a showing of good cause is filed as provided in paragraph 2, a hearing on the question shall beheld on April 19, 2011 at 9:00 am before the Honorable CAROL E DRAPER, County Judge, in COURTROOM 4E, at the Osceola County Courthouse, Kissimmee, Florida.
4. If no showing of good cause is filed within the time specified and/or no one appears at the hearing specified in paragraph 3, this action shall stand dismissed for want of prosecution on the date specified in paragraph 3 without further order of court.
