On February 16, 2015 I (Helen Pearce) filed a report with the Osceola Sheriff Department, because Craig Allen Rairdin has been cyberstalking my family and me.

We became acquainted with each other over a year ago. He had a home listed for sale by an ad on the internet that we inquired on. There was no offer made, simply expressed interest.

February 14, 2014 he began a course of conduct that has caused substantial emotional distress and it serves no legitimate purpose. His most recent actions have caused my family and I to be fearful and distressed.

The incident that caused me to report it to the Sheriff Department was contact through our work website that included mine and my husbands names, our address, stating that we were going to be on Channel 6 news and a link to a YouTube video. It is a music video for the song: Drowning Pool-Bodies.

Some of the lyrics: "Let the bodies hit the floor...nothing wrong with me...push me again, this is the end, skin to skin, blood and bone...driven by hate, consumed by fear...Let the bodies hit the floor..." Although Doug did not directly type those words himself I saw it as a threat that he was using someone else's words (this song) to say on his behalf.

Most importantly to me and my husband is that Doug has included my children in the Cyberstalking.

- \* He has made mention of finding all of us Facebook (which all of our accounts were on private settings, but immediately deactivated).

- \* He has threatened several times that he will separate my children from me.

- \* DCF received a tip that our children were being abused. I informed the worker Lori Fusco of the case and gave her their information. She informed me that she will be looking more into the source of the tip. This happened just yesterday (2/17/15) while I was at the courthouse getting the injunction started.

Craig posts on a blog he created: [www.craigr.com](http://www.craigr.com) regularly. He discusses how he tracks us, posts where we frequently go, our names, addresses, pictures that are copywrited, boasts of being related to different government branches, and encourages others to join in. All of these comments are malicious, slander and libel to make us feel threatened, defamed and fearful.

When he began his blog was per the usual as posts on a personal blog would be. However, over time he added information about Helen to his home page more and more. The majority of his home page is now dedicated to Helen. There is an entire page dedicated to sending them reports of information that anyone can find.

He has boasted on this blog of creating an app, specifically just to track all of us, that will find more information for him to share and use to twist to his harassing behavior.

He has posted similar comments with this information and links to that particular website on several social media sites.

He allows comments from Doug Hill and suggest that others contribute to his cyberstalking and cyberbullying. He boasts of the advances they have made as a team together in hunting me, my husband, my children, family, friends, etc.

He contacted Helen through the work website on three different occasions. These communications were written as if they were from Helen's parents, sister and Matthew's parents. They were signed as if they were from them (Tracy & Ken Clapp, Wilfred & Glatha Tate, Renee & Rick Pearce). Of course after checking with them, they had not sent that communication.

He has publicly posted on Craigslist in different locations on the community section with deceitful and false claims. They are very slanderous and encourage people to go to the blog at [www.craigr.com](http://www.craigr.com). Our picture is posted in the ad as well.

He has boasted of tracking down the route that my husband uses to run daily.

He boasts on this blog that he has contacted the sheriff department and filed numerous reports along with threats to be fearful of going to jail, being arrested etc.

He invites people to comment and join in. They claim to be part of a team that is working together to cyberstalk and cyberbully. They have used their own emails as well as anonymous (boondocksavedsaint@hotmail.com)

He invites hate and has made my family and I a target to others who have seen all of the things that he's put online. I am fearful that others have been encouraged to act out of hate and I am fearful for my family's safety and well-being. They have done everything they can to cause division between my family and I; to defame and discredit us in our community and through this course of conduct has become a credible threat. He mentions in different areas of his blog that he has "no dog in this race," that he has never done never done any type of business with me and has no legitimate complaint. That it's simply for his entertainment. His behavior has caused substantial emotional distress along with fear and anxiety of what he may do next or fear that he will follow through with his threat of violence. None of his actions have served any legitimate purpose and I request that an injunction be placed for our protection.
